Past Performances

Training at CDER Office of Computational Science (OCS)

DRT has supported CDER OCS for over eight years, designing, developing, and managing a training program on OCS analytical tools, Data Standards, and Digital IND Safety Reporting. Our team uses our Learning Framework to implement standard processes, tools, and templates throughout the training lifecycle and across all OCS training projects to deliver a consistent training experience to reviewers. We support the development and delivery of classroom and online training, on-demand eLearning content using tools like Camtasia, and hands-on workshops to provide reviewers with accessible, relevant, and timely training. We use Saba, the Department of Health and Human Services' (HHS's) Learning Management System (LMS), to develop and publish training offerings, manage and track registration and attendance, and complete reconciliation and closeout of each training offering. In 2019 DRT supported OCS in delivering classroom training and workshops to 560 students, with 93% of students surveyed rating the training as "Excellent" or "Very Good."

Records Management & Information Program Support at FDA Center for Food Safety & Applied Nutrition (CFSAN)

DRT supported the FDA/CFSAN/DITM (Division of Information Technology Management, formerly BIS) with their Records Management and Information program, providing direct support to the scientists of CFSAN on records management practices, statutes, and policies. We collaborated extensively with the FDA-governing Records Management team to ensure CFSAN was employing appropriate records management processes and procedures identified by National Archives and Records Administration's (NARA) directives and Federal records management-related statutes and regulatory requirements. DRT supported DITM in records management of physical records inventory, retention scheduling, scanning, records transfer, search and retrieval of documents and information, and the storage of physical and electronic records. We leveraged our domain knowledge of records management at FDA to support CFSAN's records management training program by developing training materials and a user guide for the Documentum software tool used as the FDA document repository. DRT supported the efforts to ensure all CFSAN employees were compliant. Over the last two years, DRT has helped CFSAN achieve 100 percent training completion by all CFSAN employees.

Information Systems Engineer Functional & PME Course Implementation Training & Support (AOC 26B)

Kaiva Tech provides two CCNA instructors for the Fort Gordon Cyber Center of Excellence Signal School Cisco Training Academy and one instructor for Host Based Security Systems (HBSS) and Assured Compliance Assessment Solution (ACAS) training. CCNA Instructors are required to possess a current CCNA certification as well as the Cisco Net Academy Instructor certification. CCNA instructors provide classroom instruction and hands-on training on four semesters of training, each semester is conducted within a 9-day period consisting of on-line training and evaluation, daily classroom instruction, practical hands-on exercises and examinations utilizing both packet tracer software and physical Cisco router and switch equipment. Instructors provide training required for students to successfully complete all four semesters of training for both written and performance examinations prior to attempting the actual Cisco CCNA (Routing and Switching) certification.

The HBSS/ACAS instructor is a part time position that provides 40 hours of instruction on McAfee's ePolicy Orchestrator Host Based Security System and Tenable/Nessus' Assured Compliance Assessment Solutions Security Center functions for active and passive compliance and security scanning. Both HBSS and ACAS instruction is provided in a classroom environment with lecture and hands-on performance exercises and evaluations. The use of virtual VmWare software is configured on the instructor computer for ePolicy Orchestrator and Security Center of which students have the ability to access from individual workstations to administer software policies and scanning of classroom systems with all functions available as if in a real-world environment.
